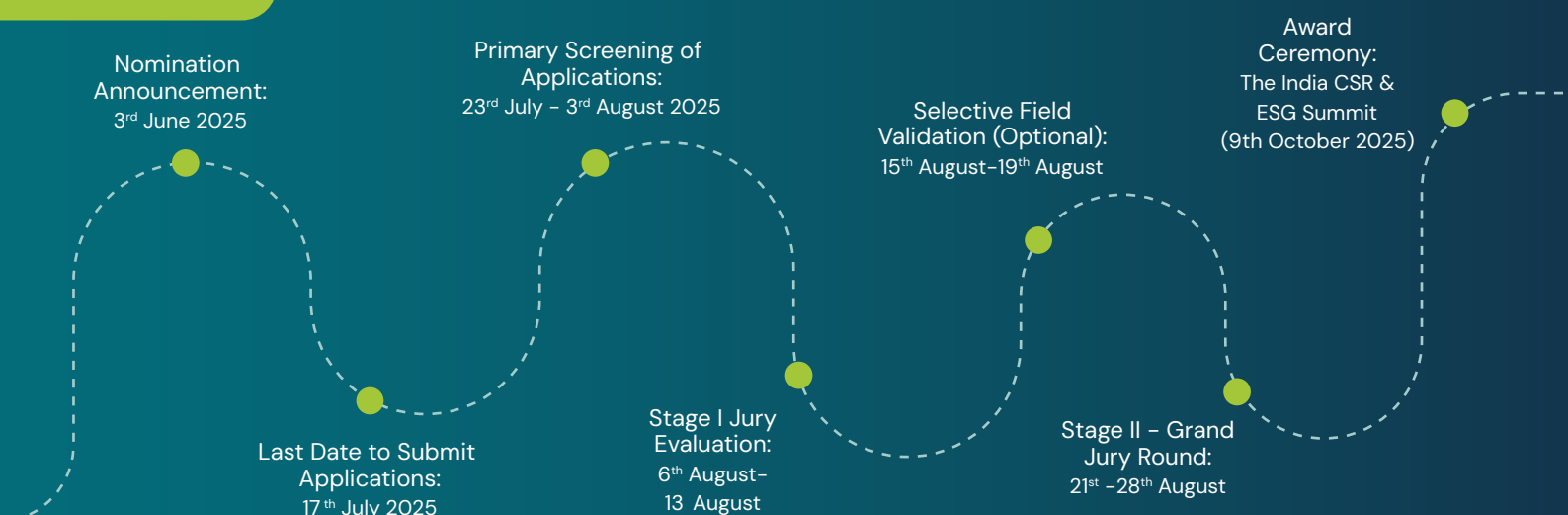
The "Doing Good for Bharat Award 2025" represents a visionary initiative aimed at honouring outstanding contributions in the realms of community, climate, and conservation. It acknowledges the contributions of individuals, businesses, organisations, and government entities actively promoting social and environmental development, fostering transformative impacts all across Bharat. By celebrating initiatives that advance sustainable development, the DGB Awards aim to inspire continued efforts towards creating a more inclusive, sustainable, and prosperous future for Bharat.

Objectives of the Awards

The primary objective of the awards is to acknowledge and promote outstanding contributions made by various entities towards the betterment of society and the environment. These awards seek to:

- 01** | **Highlight and reward exemplary initiatives** that have created significant and measurable impact on communities and the environment.
- 02** | **Encourage innovation** by recognising solutions that effectively address pressing social and environmental challenges, with a focus on scalability, replicability, and evidence-based outcomes.
- 03** | **Recognise and motivate diverse changemakers**—including individuals, businesses, academic institutions, social enterprises, and non-profits—for their commitment to creating positive social and environmental outcomes.
- 04** | Provide a unified platform to honour the efforts of organisations, government officials, community leaders, and volunteers who are making meaningful contributions towards inclusive and sustainable development.
- 05** | **Inspire continued action** by celebrating 'good doers' and encouraging a culture of responsibility, equity, and sustainability in every sphere of society.

The Awards' applications/nominations assessment is based on Projects/Programme executed in the financial year 2023-24 and 2024-25. The project/programme should have been implemented in one or both of these years. The "Doing Good for Bharat" Awards encompass a wide range of categories, acknowledging efforts across various sectors:

✓ Who Can Apply:

- Businesses and Corporates

✓ Eligibility Criteria

- The applicant must be a company registered with the Ministry of Corporate Affairs (MCA), Government of India, or operating under the guidelines issued by the Reserve Bank of India (RBI).
- The company must have recorded a minimum annual revenue of INR 500 crore or more in the financial year 2024–25, in accordance with the recognised Indian Accounting Standards.
- The nominated project, programme, initiative, or a group of activities must have had a funding outlay of INR 40 lakh or more in either:
 - FY 2023–24, or
 - FY 2024–25, specifically through CSR expenditure.
- It is mandatory to submit supporting documents for verification of eligibility. These include:
 - Certificate of incorporation or equivalent registration proof
 - Audited financial statements of the last 2 years
 - Project financial summary or utilisation report
 - Any additional documents to support during the evaluation process

B. Doing Good Through Business: Social Responsibility

✓ Who Can Apply:

- Businesses and corporations eligible for CSR spending as per the Section 135 of the Companies Act 2013.

✓ Eligibility Criteria

- The applicant must be a company registered with the Ministry of Corporate Affairs (MCA), Government of India, or operating under the guidelines of the Reserve Bank of India (RBI).
- The company must have recorded a minimum annual revenue of INR 500 crore in Financial Year 2024–25, as per the recognised Indian Accounting Standards.
- The nominated project, programme, or group of initiatives must have a minimum funding outlay of INR 40 lakh in either:
 - FY 2023–24, or
 - FY 2024–25, specifically through CSR expenditure.
- It is mandatory to submit supporting documents for verification of eligibility. These include:
 - Certificate of incorporation or equivalent registration proof
 - Audited financial statements of the last 2 years
 - Project financial summary or utilisation report
 - Any additional documents to support during the evaluation process

C. Doing Good through Innovation (Start-up/Social Enterprise)

✓ Who Can Apply:

- An entity registered with the Ministry of Corporate Affairs (MCA), Government of India, under the Companies Act (excluding Section 25/Section 8 of the Companies Act, 2013), or
- A registered for-profit organisation, including Partnership Firms or Proprietorships

✓ Eligibility Criteria

- The organisation must be a registered for-profit entity operating in India
- Must have been in legal operation for a minimum of 2 years as of 1st July 2025
- Must have a minimum full-time team size of six (6) members
- Should have reported a minimum revenue of INR 25 lakhs in FY 2024–25
- Must offer fully developed solutions addressing specific social or environmental challenges in India, with a demonstrated use case or on-ground implementation.

- The solution should show evidence of impact, adoption, and scalability potential.
- Submission of supporting documents for eligibility verification is mandatory, including:
 - Registration certificate
 - Audited financial statements of the last 2 years
 - Team structure (organogram with names & designations of all key team members)
 - Case study or documentation of implemented solution

D. Doing Good through Grassroots Actions (NPOs)

✓ Who Can Apply:

A registered non-profit organisation (Section 8/25, Society or Trust) a non-profit implementing organisation and Corporate Foundations (Irrespective of funding source)

✓ Eligibility Criteria

- Entities registered in India as a:
 - Section 8 Company under the Companies Act, 2013
 - CSR Foundations
 - Public Charitable Trust
 - Society registered under the Societies Registration Act, 1860 or relevant state legislation
- Eligibility Requirements:
 - The organisation must have completed at least five (5) years since the date of registration, as of 1st July 2025
 - Must have implemented projects or initiatives with a minimum funding outlay of INR 40 lakh in either FY 2023–24 or FY 2024–25
 - Projects should demonstrate tangible social or environmental impact, preferably with a focus on sustainability and replicability
- Submission of supporting documents is mandatory for verification and may include:
 - Registration certificate and relevant legal documents
 - Audited financials for FY 2023–24 or FY 2024–25
 - Project details with funding and impact evidence (reports, case studies, etc.)

E. Philanthropy for Impact (Philanthropic Organization/ Individual Philanthropists/ Family Offices)

✓ Who Can Apply:

International or national philanthropic organisations (including foundations, trusts, or endowments) that are actively engaged in funding or supporting social impact initiatives in India.

✓ Eligibility Criteria

- The organisation must have contributed or invested a cumulative amount of at least INR 5 crore in Indian social impact initiatives across FY 2023–24 and FY 2024–25.
- Contributions can be in the form of grants, donations, or programmatic investments directed towards non-profit, development, or SDG aligned interventions in India.
- Applicants must submit supporting documentation to validate investment figures and the nature of supported initiatives. This may include grant agreements, audited financial statements, impact reports, and utilisation certificates.
- Individual philanthropists and family offices that have supported multiple organisations or projects across sectors and regions within the specified timeframe are also eligible to apply, provided their cumulative contributions meet the INR 5 crore threshold and align with the social impact and SDG criteria outlined above.

- Currently serving or previously served civil servants (IAS or equivalent officers) at the district, state, or national level.
- Highlighting impactful and verifiable initiatives or Programme led by the nominee that have made a meaningful contribution in the fields of Healthcare, Education, Environment, or Tech for Good, at the selected sub-category level—District, State, or National.
- The initiatives must have been implemented at the district, state, or national scale, demonstrating innovation, replicability, and tangible impact.

Applying as an Organisation

A. Doing Good Through Business: Environmental Stewardship through CSR/Business Intervention/ESG and Sustainability: Recognising businesses integrating social and environmental responsibility into their core operations and corporate citizenship

- **A1. Doing Good for the Planet (Jal, Jungle, Zameen, Vayu)**

Recognising holistic environmental initiatives spanning water, forest, land, soil, and air. This includes conservation, pollution mitigation, biodiversity protection, climate resilience, and sustainability integration within core business operations.

B. Doing Good Through Business: Social Responsibility: Recognising businesses and corporations for their CSR initiatives.

- **B1. Doing Good for Education**

Honouring corporate initiatives enhancing access to quality education through innovative pedagogy, technology use, or infrastructure that leads to transformative learning outcomes.

- **B2. Doing Good for Healthcare**

Celebrating CSR efforts that strengthen healthcare systems, infrastructure, and services, aiming to improve public health and well-being.

- **B3. Doing Good for Women and Inclusion, Employability & Livelihood**

Acknowledging programmes that empower women and marginalised communities, improve employability, support entrepreneurship, and generate sustainable livelihoods.

- **B4. Doing Good for Rural Development**

Recognising initiatives that drive socio-economic development in rural areas through infrastructure, basic services, and income-generation activities.

- **B5. Workforce for Good (EVP)**

Highlighting efforts to foster employee volunteerism and community engagement within corporate structures, measuring workforce participation and social impact.

C. Doing Good through Innovation (Start-up/Social Enterprise): Acknowledging startups, social enterprises, and other for-profit entities for their innovative solutions that drive social and environmental progress.

- **C1. Doing Good for Water**

Recognising innovative water-related solutions that address accessibility, conservation, treatment, or efficient use, with proven scalability and community impact.

- **C2. Doing Good for Agriculture**

Celebrating impactful agri-innovations enhancing productivity, sustainability, soil health, and farmer incomes through technology or novel models

- **C3. Doing Good for Waste Management**

Honouring entrepreneurial solutions targeting solid or liquid waste reduction, segregation, recycling, or reuse through circular economy approaches.

D. Doing Good through Grassroots Actions (Non-Profit Organisations, NPOs): Recognising impactful initiatives at the community level by implementing organisations, irrespective of funding sources.

- **D1. Doing Good for Education**

Applauding NPO-led efforts that improve access to and quality of education, particularly among underserved communities.

- **D2. Doing Good for Healthcare**

Recognising community-level healthcare programmes enhancing access, awareness, and outcomes through non-profit intervention.

- **D3. Doing Good for Women and Inclusion, Employability & Livelihood**

Honouring grassroots actions that support women's empowerment, inclusivity, employability, and livelihood creation.

- **D4. Doing Good for Rural Development**

Celebrating rural development initiatives by NPOs that lead to enhanced quality of life, infrastructure, and economic opportunities.

- **D5. Doing Good for the Environment (Land, Water, Air and Forest)**

Acknowledging impactful environmental protection and restoration efforts led by NPOs across natural resource categories.

E. Philanthropy for Impact (Philanthropic Organisation/individual philanthropists/ family offices): Recognising exceptional philanthropic contributions towards social good and environmental sustainability.

Celebrating philanthropic leadership that drives social and/or environmental transformation through strategic investments, partnerships, and ecosystem building.

2. Applying as an Individual: Nomination for Outstanding work through Governance and Public Services

Through this category, we are recognizing the efforts of civil servants in creating a better society and planet. We invite nominations from individuals and organisations for district, state, and central-level civil servants who have demonstrated transformative leadership and have been change-makers in specific areas.

F. Doing Good through Governance and Public Services (Healthcare/Education/Environment/Tech for Good) : Recognizing Exemplary Government Initiatives Creating Positive Social Change in

◦ **F1. District Level**

Recognising district-level public servants who have driven transformative outcomes in education, healthcare, environment, or tech-enabled developmental governance.

◦ **F2. State Level**

Honouring state-level leadership for impactful policy implementation, governance reform, or programme delivery in priority development areas.

◦ **F3. National Level**

Applauding national-level governance efforts that demonstrate scalable, systemic change in key areas such as gender, sports, education, health, environment, or digital innovation.

One award would be awarded in each sub-category. However, the Grand Jury would be empowered to select more than 1 winner in each category.

- Celebrate winning partnerships at the prestigious award ceremony.
- Receive media coverage and outreach for your project's impact.

Award-Application Benefits

- Applicants/applications qualifying for Stage 1 will receive one delegate pass (Non- Residential Delegate Pass with Lunch)with full access (excluding restricted areas) to the India CSR and ESG Summit 2025, held on the 7th, 8th, and 9th October 2025.
- An additional pass will be granted to the winning applicant, individual, or organisation with full access (excluding restricted areas) to the India CSR and ESG Summit 2025 (Hotel Pullman and Novotel, Aero City, New Delhi). Additional passes can be purchased from the online registration counter.

Application Fees

There is **no application fee** for submitting nominations for the "Doing Good for Bharat" Awards. The process is designed to be inclusive and accessible to all eligible participants.

Applications Assessment Process and Methodology

For Doing Good for Bharat Awards 2025

The evaluation of applications will follow a rigorous and multi-stage process designed to ensure fairness, transparency, and recognition of true impact. Here's how the selection journey unfolds:

Primary Screening

- Only the top 20% of applications or a maximum of 12 entries per sub-category (whichever is lower) will progress to the next stage.
- The screening will be conducted by the Impact Practice Team at CSRBOX, along with at least 5 prestigious organisations in the sector as screening partners. The names of these external partners will be announced by July 2025. Last year, esteemed organisations such as ISDM, Sattva, GT, SPJIMR, ISDM partnered with us in this stage.

Stage I: Expert Jury Evaluation

- A Stage I Jury Panel consisting of 3 experts from diverse social and environmental domains will evaluate the shortlisted entries.
- The jury will nominate the top 3 applications per sub-category to proceed to the Grand Jury round.
- An optional field validation of these top applications may be carried out by the CSRBOX team and relevant domain experts to verify on-ground impact.

Stage II: Grand Jury Round

- Each sub-category will have a Grand Jury of 3 highly experienced professionals from the social impact, sustainability, and development sectors.
- Evaluation will take place either in person or virtually.
- Shortlisted applicants will receive clear presentation guidelines and instructions at least 4 days before the Grand Jury round.
- One winner will be selected in each sub-category. However, the Grand Jury reserves the right to recognise more than one winner, depending on the merit of applications.

Note: There will be a separate independent jury for Stage I and Stage II.

Terms and Conditions

- **Doing Good for Bharat Awards 2025** (An initiative by CSRBOX (Renalysis Consultants Pvt. Ltd.))

The Doing Good for Bharat Awards aim to recognise the exemplary efforts of organisations, corporates, individuals, government officials, community leaders, and volunteers who are driving positive change in the social and environmental landscape of India. This platform celebrates those who are committed to building a better, more inclusive and sustainable Bharat.

- **Fair and Transparent Process**

All applications will be evaluated through a clearly defined and transparent assessment process. By submitting an application, participants agree to the terms, process and decisions laid out by the organisers and evaluation panel.

- **Application Validity**

Only complete applications fulfilling all eligibility criteria and submitting the required documents will be considered for evaluation.

- **Submission Requirements**

Applications must be submitted online through the official application link. Required documents include the completed application form, proof of eligibility, detailed initiative description, evidence of outcomes and impact, and any necessary endorsements or letters of recommendation.

- **Due Diligence**

Organisers may request additional details or clarification during the assessment process. Applicants are expected to respond promptly and accurately.

- **Single Submission per project**

Each project may be submitted either by the implementing agency or the corporate partner. To ensure fairness and avoid duplication, we kindly request that the same project is not submitted by both parties. In case multiple entries are received for the same project, only the first submitted application will be considered. Applicants are encouraged to coordinate in advance and mutually decide who will submit the nomination.

- **Accuracy of Information**

It is the responsibility of the applicant to ensure that all information and documents provided are accurate and verifiable. If any information is found to be false or misrepresented at any stage, the application will be disqualified.

- **Screening and Shortlisting**

All applications will undergo an initial screening after the close of registration. Shortlisted entries will move forward to further evaluation stages.

- **Notification to Winners**

Selected winners will be informed at least 10 days prior to the India CSR and ESG Summit 2025.

- **Minimum Entry Clause**

In case fewer than five entries are received in a particular sub-category, all applicants from that sub-category will be directly moved to Stage II of the evaluation.

- **Sub-Category Limit**

Applicants may apply for up to two sub-categories only. If more than two are selected, only the first two submitted will be taken into consideration.





Parameter for Primary Screening:

- Applications will be shortlisted based on their compliance with the eligibility criteria outlined in the application guidelines. Only those who submit all mandatory documents and complete the due diligence process will be considered.
- Required documents include the completed application form, proof of eligibility, a detailed description of the project or initiative, evidence of outcomes and impact, and any necessary letters of recommendation or endorsements.

Parameter for Assessment:

- All applications will be carefully reviewed by an expert jury based on the details shared in the application form, including supporting documents and relevant links. Each entry will be assessed against a set of well-defined parameters.
- Organisations and individuals will be evaluated on their overall commitment to CSR and sustainability, and compared with others in their respective categories. Key evaluation criteria include the effectiveness, innovation, creativity, sustainability, and long-term impact of the initiatives or contributions.
